Minutes of the Annual Council Meeting held at George Nympton Village Hall May 19 2015

- **Councillors Present:** Trudy Herniman, Roger Gay, Mark Dean, Trevor Allen, Mike Miller, Richard Toller The meeting opened at 7.34pm
- **2015/001** Election of Chairman Trudy Herniman was unanimously elected
- **2015/002** Election of Vice-Chairman Roger Gay was unanimously elected
- **2015/003 Delivery of Declarations of Acceptance of Office** The Chairman and Vice-Chairman completed these, witnessed by the Clerk
- **2015/004** Apologies/Attendence Register Apologies received from Mike Monaghan who is away and Sarah Leworthy who is sick.
- **2015/005 Disclosable pecuniary interests** There were none
- **2015/006 Announcements from the Chair** There were none.
- **2015/007** Questions from the Public There was a complaint about the drain repairs, Trevor Allen explained it is getting very difficult to liaise with the Highways department, their standard answer seems to be there is no money. Village Hall changes, Lloyd Ayre now Chairman and Jane Smith will be keeping the diary and will be holder of the main key.
- 2015/008 Minutes of the previous meeting All agreed and signed by the Chairman.
- **2015/009 To consider any dispensation requests -** None requested.
- **2015/010 Police Report** –An e mail was received from P.C. Adrian Micallef, no reported crimes, there was one call received in April regarding a shot being heard, source not found, but likely to be people out lamping.
- **2015/011 Review of delegation arrangements to local organisations** Mike Miller for the Church and Sarah Leworthy for the Village Hall.
- **2015/012** Settings the dates, times and place of Ordinary meetings of the full council for the year ahead All to be held at the Village Hall 7.30pm, dates as follows July 14th, Sept 17th, Nov 19th, Jan 21st and Mar 17th.
- **2015/013 Planning Matters** Nothing received.
- **2015/014** Local Plan for Village Trevor Allen has agreed to speak to Ian Bateman and will try to establish a steering group to move this forward.
- **2015/015 County Councillor's slot** Jeremy Yabsley said there will be a Parish Survey to be completed by the Highways department because they need to make further cuts. This survey intends to find lanes that can be downgraded from Highways to Public Right of Ways saving them money on upkeep.

The Electoral Review of Devon has made draft recommendations to move certain boundaries based on numbers of electors. Given that a large part of the county is very rural this will change things for the communities and the county councillors, details of this plan have been advertised on the village board and Jeremy would like people to give comment.

2015/016 District Councillor's slot – Jeremy spoke on behalf of Eric Ley - Because of the Election no leader has yet been chosen for the District Council yet, it should be decided by the 26th May. The Local Plan is progressing should be finished in August. Planning regulations re barn conversions have been relaxed.

Church – On 7th June 2015 there will be an 'Open Gardens' in the village to raise funds for the stain glass windows in the Church, a leaflet has been distributed with all the details.
